Respected Sir,

We are getting on to strengthen the futures of students with the help of NEP 2020 with aims to provide infrastructure support, innovative education centers to bring back dropouts into the mainstream besides tracking of students and their learning levels, facilitating multiple pathways to learning involving both formal and non-formal education modes and association of counselors or well-trained social workers with schools. Where as some entities are operating in the field of education without permission and not established by Law. One such entity is Board of Higher Secondary Education, Delhi as said in the Public notice issued by Department of School Education and Literacy, Ministry of Human Resource and Development, New Delhi Date: 26 July 2019 to General Public, all students, their parents and all other stakeholders is as under.

- 1. 'It is hereby informed to the general public that it has come to the notice of this Ministry that one entity operating in the name of "Board of Higher Secondary Education, Delhi" is claiming to be a recognized Board of Education by this Ministry vide letter No. 1812/2009/SKT-1 dated 29/06/2009 and D.O. letter No.3-5/2013/Sch.3 dated the 26<sup>th</sup> April, 2013. On scrutiny of the relevant records of this Ministry, it has been found that no such letters have ever been issued by this Ministry in favour of so called Board of Higher Secondary Education, Delhi. Both these letters are, therefore, completely forged and fabricated. Further, it is abundantly clarified that no letters, whatsoever, have ever been issued by this Ministry recognizing the said entity i.e. Board of Higher Secondary Education, Delhi.
- The said entity i.e. Board of Higher Secondary Education, Delhi stands dissolved w.e.f. 01.07.1962 vide Directorate of Education Delhi Administration Resolutions No. F. 32(10)62-Edn. dated 30.06.1962. Therefore, if any other document(s) is/are produced by the Board of Higher Secondary Education, Delhi in relation to its

- recognition, then the same may be deemed to be fake and the veracity of the documents may first be got confirmed from the concerned organization/Ministry.
- 3. The General Public, all students, their parents and all other stakeholders are, therefore, advised to take note of the above facts and act accordingly.'

The copy of above Public notice is attached herewith.

COBSE grants membership to boards/institutions that are set up by an Act of Parliament or State Legislature or by an Executive Order of the Central/State Government and broadly follow the National Curriculum Framework/CBSE. The Board of Higher Secondary Education, Delhi does not hold the membership of COBSE. Whereas the board of all the states holds the membership of COBSE. There are 65 associated members of COBSE at present.

Gujarat Secondary & Higher Secondary Education Board, Gandhinagar issues equivalency certificate to the students of member Board of COBSE only. Therefore the issuance of equivalency from Gujarat Secondary and Higher Secondary Education Board to the students of Board of Higher Secondary Education, Delhi is not given till today. This matter is sub judicial vide SCA No.12013/2018 in the Hon. High Court of Gujarat. We can't allow such fake Board to misguide the students.

We request you to take necessary preventive steps to stop entities operating without permission and not established by Law in the field of Education so to avoid students becoming its victim.
